- iv) At least 1 credit course of computerized Engineering Drawing shall be offered in respect of CSE, IT and AI & DS branches.

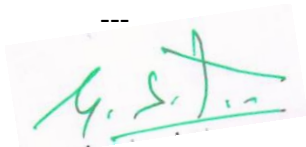

❖ **Autonomous Academic regulations**

- Review of Question Papers should not be done by the internal faculty. Clear template should be given to the external Experts for the preparation of Question Papers. The review of the question papers before the examination is removed from the regulations.
- Moderation can be done during the time of evaluation or after the evaluation.
- Credits should be maintained as 180 per program: the course structure is modified to maintain 180 credits in all branches of engineering.
- Promotion policy should be made it clearly in the regulations: It resolved that to promote to 5<sup>th</sup> semester the student must get a minimum of 50% credits considering 4<sup>th</sup> semester examination. To promote to 7<sup>th</sup> semester the student must get a minimum of 50% credits considering 6<sup>th</sup> semester examination.
- Students should aware of the academic regulations at the time of orientation itself.

Academic regulations are ratified subject to implementation of the above suggestions.

❖ **Ratification of course structure, syllabi**

- In the next Academic Council meeting it is decided to reconstitute the BOS as the their time is expiring after 2014-15 academic year and it is suggested to include professors from reputed institutions like IIT,s and NIT,s
- Industry ready course structure to be framed.
- Any one of the Certification courses should be done by the students and it is made mandatory for them to get awarded the degree. These certification courses will be taught after the regular class work for a particular duration.
- Syllabus should be different from other Institutions.
- Good external experts from IIT / NIT / University are to be identified and invited.

Course structure and syllabi is ratified from the academic year 2014-15.

#### ❖ **Ratification of examination process**

- The word “list of examiners” should be replaced with the word “Panel”. HODs should suggest the Panel to the Chief Superintendent of Examinations i.e. Head of the Institution for the finalization.
- Revaluation should be done carefully.
- Challenge evaluation to be implemented in case of necessity only. It is decided to remove the challenge evaluation.

Examination process is ratified subject to implementation of the above suggestions.

- Principal explained the meritorious scholarships, awards, prizes and medals being given to the toppers of college.
- Members suggested that good rankers of EAMCET can be given fee waiver ensuring that student is not getting any Scholarship from Govt. and this proposal should be presented to Governing Body for its approval.

#### ❖ **Introduction of new programs and closing of existing programs, if any**

- Principal briefed about the existing Courses being offered and their intake.

It is decided to close the MCA course keeping in view of the placements as well as zero admission this year.

#### ❖ **Co-curricular activities / Sports**

- Co-curricular / Sports activities are explained by the Principal.

#### ❖ **NBA / NAAC Accreditation**



- Members suggested going for NBA accreditation in respect of the PG courses also.
- Members informed that NBA inspection is expected in the month of September 2014.
- NAAC Inspection team has to visit the college for accreditation.

❖ **Any other items with the permission of the Chair**

- Shortage of attendance is discussed and norms & procedure are framed.
- For successful implementation of autonomous status, faculty has the key role to play.
- Latest text books and e-books to be utilized in framing the syllabi.
- Student may also be allowed to bring their Laptops into the Classrooms for interactive learning.
- R&D to be given more importance.
- The best procedures / practices of other autonomous colleges to be observed for implementation if requires.
- Every faculty (including fresh one) member should aware of the procedures and regulations of autonomous status. Orientation should be arranged for the staff.
- As grading is awarded based on CGPA, it would be better if all the subjects have the maximum marks of 100.
