3. FUTURE PLANS

i. JNTUK Research Centre

ii. Change in learning experience for specified subjects

vii. Appraisal System for Faculty – Development in line with UGC

HODs shall be instructed to sit with the faculty individually in the beginning of the semester itself and fix the specific targets to be achieved during that semester. It is suggested to identify three to five criterion and motivate the faculty to achieve them. After completion of the semester, again HODs shall sit with the faculty individually and review shall be done. Based on the HODs' review, Principal will give the marks, categorise the faculty and find out the causes for slackness, if any, and non-performing faculty will be sent to VEDIC and given one more year chance for improvement.
