20.1. PREVIOUS ACADEMIC COUNCIL MEETING:

a. Confirmation of the minutes

The Council unanimously ratified the minutes of the 19th Academic Council meeting, held on 18 October 2023, as previously circulated to all members.

20.2.RATIFICATION OF RESULTS:

The Chairman presented an exhaustive report to the Academic Council, detailing the performance metrics and comparative analyses for both Regular and Supplementary examinations conducted during the first and second semesters of the 2022–2023 academic year. The report encompassed overall pass percentages, programme-wise and course-wise performance trends, distinctions earned, and year-on-year progress indicators, thereby providing a holistic view of student achievement and academic rigor. After a thorough deliberation on the data, methodologies employed, and quality-assurance measures in place, the Council expressed its appreciation for the commendable outcomes demonstrated by the student body. Consequently, the members resolved—without dissent—to formally approve and confirm the examination results in their entirety. This resolution authorises the Office of the Controller of Examinations to publish the sanctioned results, initiate the issuance of grade cards, and proceed with any subsequent academic processing required under the University's regulations.

20.4.Resolution — Approval of the R23 Second-Year Syllabus

The Academic Council considered the proposed curriculum for the second year under Regulation 2023 (R23). After due deliberation, the Council resolved as follows:

- **20.4.1.** Confirmation of Prior Approvals
 - ✓ The first-year R23 syllabus, earlier endorsed by the respective Boards of Studies (BoS) and subsequently ratified by the Academic Council, stands confirmed.
- 20.4.2. Second-Year Curriculum Endorsement
 - ✓ The Council noted that the detailed second-year course structure and syllabi were scrutinised by the relevant BoS during the current week and unanimously recommended for adoption.
 - ✓ Acting on these BoS resolutions, the Academic Council hereby approves and ratifies the entire second-year R23 syllabus.
- 20.4.3. Framework for Subsequent Years
 - ✓ The proposed course structures for the third and fourth years will be tabled at forthcoming BoS meetings. Their recommendations will be presented to the Council in due course for final approval.
- 20.4.4. Alignment with JNTUK Guidelines
 - ✓ For cohorts admitted from Academic Year 2023-24 onward, the institution will follow the curriculum framework prescribed by Jawaharlal Nehru Technological University, Kakinada (JNTUK) as its baseline.
- 20.4.5. Autonomous Curriculum Flexibility
 - ✓ In recognition of the college's autonomous status and its cadre of experienced faculty, the Council reaffirms that up to 25 %-50 % of the university-specified content may be modified to better meet contemporary academic and industry needs.
 - ✓ The Council further records that JNTUK imposes no objection to such calibrated revisions, provided core learning outcomes are preserved.

- 20.4.6. Sanction and Implementation
 - ✓ The Academic Council grants its formal approval to all proposals presented, authorising the immediate implementation of the R23 second-year syllabus and any duly endorsed amendments.
 - The Dean (Academics) is entrusted with disseminating the approved curriculum to all departments and ensuring timely publication in the official handbook and learning-management systems.

This resolution takes effect forthwith.

20.5. R23 3RD & 4TH YEAR COURSE STRUCTURE

R23 $3^{rd} \& 4^{th}$ years Course Structure is placed before the members and it is approved and ratified by the Academic Council.

20.6. 2024 PASSEDOUT BATCH PLACEMENTS DETAILS

Council members noted the encouraging trajectory of the current figures and commended the continuing effectiveness of the institution's corporate engagement strategy. They emphasised the importance of sustained outreach to emerging sectors, targeted skillenhancement initiatives, and proactive support for students yet to be placed.

Accordingly, the Council resolved to:

- ✓ Take the placement statistics on record as presented, recognising them as a positive indicator of the institution's industry linkages and employability initiatives.
- ✓ Direct the Placement Cell to intensify its efforts during the forthcoming recruitment cycles—particularly in high-growth domains such as product engineering, data science, and sustainability technology—to secure further opportunities for the remaining unplaced graduates.
- ✓ Request a comprehensive end-season report at the next Council meeting, detailing final placement metrics, recruiter feedback, and actionable recommendations for the 2025 cohort.

This resolution stands approved and will be communicated to all concerned departments for implementation and monitoring.

20.7. Resolution — Minimum Pass Criterion under Regulation 2023 (R23)

After due consideration, the Academic Council ratifies the following assessment standard for all courses governed by the R23 syllabus and course structure, effective from the forthcoming examination cycle:

- ✓ For any theory paper carrying 70 external marks, a student must obtain at least 25 marks—equivalent to 35 % of the maximum—to be deemed "Pass".
- ✓ The same threshold shall be uniformly applied across all first-year and higher-semester subjects introduced under R23, unless a course is explicitly exempted by separate Council approval.
- ✓ Heads of Department, the Controller of Examinations and all course coordinators are instructed to incorporate this criterion into question-paper moderation, grading rubrics and result-processing software without delay.
- ✓ The Examination Branch shall update the student handbooks, notification circulars and Learning-Management System portals to reflect this policy and ensure clear communication to the student body.

This resolution takes effect immediately and remains in force until further orders.

20.8. Accreditation and Institutional Distinctions

The Council took note of a series of recent recognitions and quality-assurance milestones that underscore the College's sector-leading stature and sustained commitment to excellence:

20.8.1. Regulatory Endorsements

- ✓ AICTE Extension of Approval (EOA), AY 2024-25 The institution secured unconditional renewal from the All India Council for Technical Education for the forthcoming academic year, reflecting full compliance with AICTE norms and continuous fulfilment of quality parameters.
- ✓ JNTUK Permanent Affiliation Fact-Finding Committee (FFC) Review A comprehensive FFC inspection has been successfully concluded; the team's positive report has been forwarded to Jawaharlal Nehru Technological University, Kakinada for the renewal of Permanent Affiliation.

- **20.8.2.** Programme-Level Accreditations
 - ✓ NBA (Tier I) Re-Accreditation Mechanical Engineering (ME) & Civil Engineering (CE) Both programmes have earned Tier I re-accreditation from the National Board of Accreditation, valid through 30 June 2027.
 - ✓ Forthcoming NBA Re-Accreditation Applications Applications for CSE, IT, ECE and EEE programmes will be filed by December 2024 to secure continued Tier I status in the next accreditation cycle.
- 20.8.3. Autonomy & Comprehensive Assessment
 - ✓ Autonomous Status remains in force until May 2026, affirming the College's academic self-governance privileges.
 - ✓ NAAC 2nd-Cycle Accreditation The College has been awarded an A+ grade with a CGPA of 3.32/4.00, valid until October 2027, signifying excellence across all seven NAAC criteria.
- **20.8.4.** Research Credentials
 - ✓ The CSE, ECE and EEE Departments have been recognised as official JNTUK Research Centres for AY 2023-24 and AY 2024-25, enabling them to supervise doctoral scholars and undertake funded research.
- 20.8.5. National & Regional Rankings

- **20.8.6.** Professional Body Honour
 - ✓ Awarded the ISTE Mrs. Rehatun Nesa Ali Memorial Award for the Best Women Engineering College for 2023, presented at the 53 rd ISTE National Annual Convention on 22 June 2024 in Bhubaneswar.

20.9. ANY OTHER ITEM WITH THE PERMISSION OF THE CHAIR:

Academic Audit Committee Recommendations (Meeting of 14 February 2024)

The Academic Council deliberated on the observations submitted by the Academic Audit Committee and resolved as follows:

20.9.1. Normalisation & Adjustment of Marks

- Council Position Acknowledges the Committee's advice to implement a systematic normalisation protocol—once the common guidelines presently under preparation by Jawaharlal Nehru Technological University, Kakinada (JNTUK) are released.
- ✓ Action Mandate
 - The Controller of Examinations shall track the issuance of JNTUK guidelines, brief relevant HoDs and evaluation coordinators immediately upon receipt, and integrate the prescribed procedure into all forthcoming result-processing cycles.

- Pending the University's circular, evaluators are instructed to maintain current marking practices while preserving detailed grade distributions to facilitate a smooth transition to the new normalisation framework.
- A concise information note will be circulated to students once the policy takes effect to ensure transparency and manage expectations.

20.9.2. Moderation of Question Papers

- ✓ **Council Position** Endorses the Committee's recommendation that every examination paper undergo structured moderation and proof-reading prior to final approval.
- ✓ Action Mandate
 - The Principal shall constitute a three-member Moderation Panel for each subject area, comprising the course instructor, an experienced peer, and an external reviewer where feasible.
 - ➤ The Panel will verify content accuracy, alignment with learning outcomes, typographical integrity, and overall difficulty balance. Where a question must be altered or replaced, a written justification, endorsed by the Panel Chair, will be lodged with the Examination Branch for audit purposes.
 - The Controller of Examinations is directed to maintain a digital archive of all moderated scripts and supporting minutes for a minimum of five years, providing an auditable trail for internal and external quality reviews.

These resolutions take an immediate effect, and progress will be reviewed at the next Academic Council meeting.
